E**CONVICTION STATUS (REQUIRED)**

The conviction status portion must be completed. Your application may be denied for an affirmative answer. Full disclosure is mandatory. False or inaccurate information on your application will result in immediate revocation of the application.

UIL will not register anyone convicted or adjudicated with a finding of fault, guilt or violation, in regard to an offense involving a minor or any sexual offense; or, convicted or adjudicated with a finding of fault, guilt or violation, in regard to an offense involving any illegal/illicit drug or controlled substance as prescribed by Federal or State law or regulation, prior to five (5) years following the completion of any sentence/parole/probation period imposed for the offense; or, currently serving a sentence or a parole/probation period for any offense or adjudication of guilt imposed by any court, judge or administrative body.

When a currently registered official is indicted or charged with any criminal offense or charged with a violation of any statute pertaining to minors, drugs or a controlled substance, such registration will automatically be suspended, pending resolution of the indictment or charge. Conviction or adjudication of fault, guilt or violation under any such indictment or charge shall result in immediate and automatic forfeiture of the official registration. Currently registered officials must inform the UIL of any such indictment or charge **IMMEDIATELY** upon receipt of or upon having knowledge of such indictment or charge.

An official whose registration has been suspended or revoked, or an applicant who is denied registration, under the provisions of this policy, may petition for reinstatement/reapplication based on the following:

- a. If suspension, revocation or denial results from a felony: The official/applicant may petition for registration one year after the completion of the parole/probation period (provided the offense was NOT involving a minor or a sexual offense).
- b. If suspension, revocation or denial results from a misdemeanor or other non-felony charge: The official/applicant may petition for registration immediately upon the completion of the parole/probation period (provided the offense was NOT involving a minor or a sexual offense).

Check the appropriate response:

I HAVE been convicted, or adjudicated with a finding of fault, guilt or violation, in regard to an offense involving a minor or any sexual offense, an offense involving any illegal/illicit drug or controlled substance; or I am currently serving a sentence or parole/probation period for any offense or adjudication of guilt imposed by any court, judge or administrative body. (You must explain in full detail on an attached piece of paper. Include nature and date of conviction, dates and time served, probation/parole requirements, and dates of probation/parole.)

I HAVE NOT been convicted or adjudicated of an offense involving a minor or any sexual offense, an offense involving any illegal/illicit drugs, and I am not currently serving a sentence or probation/parole period for any offense.

CRIMINAL BACKGROUND CHECK. By recommendation and in cooperation with the Texas law enforcement we may be conducting criminal background checks on currently registered officials and those who apply to become an official. With Texas legislation concerning convictions and convicted persons on school grounds, this is important to protect UIL member schools, students and the UIL. In the process, officials who work the games in these schools will also be protected. I agree

G**TESTING**

Upon receipt of your properly completed application, you will be required to take appropriate tests online through the NFHS testing program. (NFHS.org) Check with your chapter contact for the specific testing deadlines. You must receive a score of at least 70% to be a local official, 80% to officiate UIL assigned playoff games and 90% to officiate at the UIL state tournament or championship level games. I agree

H**INSURANCE**

Your membership with the UIL includes an insurance package providing you with general liability, accidental medical and accidental death and dismemberment insurance through the NFHS. These coverages are automatically provided to you as part of your membership dues. There is no additional fee for this insurance program. The insurance coverage applies only while the member official is performing his/her officiating duties during regularly scheduled sports or activities competitions. Direct travel to and from sponsored activity is also covered. NOTE: No liability coverage is provided for claims that do not involve Bodily Injury or Property Damage. I agree
